

## Introduction

The Trussville Area Chamber of Commerce established its annual Small Business Awards for the purpose of honoring small businesses deserving of recognition. The 2017 recipients will be announced at our regular monthly luncheon on October 19. Winners will move on to compete in the *Alabama Small Business Awards* presented by The Partnership of the Chamber of Commerce Association of Alabama and the Business Council of Alabama. One overall Small Business of the Year will be chosen from the statewide entries to be considered for the U.S. Chamber of Commerce's *Dream Big Small Business of the Year Award*.

## Eligibility Requirements

- The nomination process is open to any independently-owned business with 100 or fewer employees that is an active member of the Trussville Area Chamber of Commerce in good standing prior to the nomination deadline.
- Nominations may be submitted by any business or person in the community. Businesses may self-nominate.
- Nominations must include answers to the Nomination Questions (see Pg. 4). Failure to provide the requested information will result in automatic disqualification.

## **Deadline**

Nominations must arrive at the Trussville Area Chamber of Commerce offices at 400 Main Street, Trussville 35173, by 4:00 p.m. on August 31, 2017. No exceptions.
